Equalisation Vessels for flow restrictors



When making steam measurements using flow restrictors, two equalisation vessels are required (DIN 19211). These vessels keep the water in the differential pressure lines at a constant level. The range of operation of the connection fittings should be determined according to the operating data at the point of measurement.

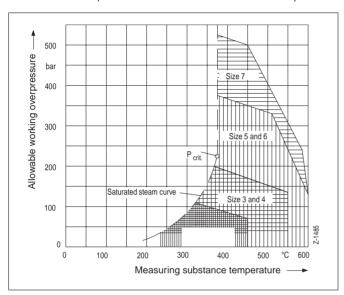
Mounting and welding are not part of the scope of supply.

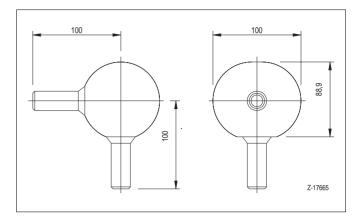
If required, the vessel (Code No. 301) can be certified with manufacturer's certificate acc. to Section 9 (2)1. of the Pressurized Containers Ordinance as well as with material certificates acc. to DIN 50049 3.1 A for the material used and is thus prepared for a subsequent overall acceptance test by the TÜV (Technical Inspectorate) at the operator's premises.

The manufacturer can make provision for individual TÜV acceptance tests of equalisation vessels with issuing of acceptance test certificates 3.1 A (costs based on the investment needed).
