Information about the latest patch level, scan engine, and virus definition file versions validated are published together with the Microsoft security update test results.

Cyber security patch updates are available as an option with all Water Care levels.

Other security services are available including NERC CIP compliance services, assistance and consultation with update installations, and solutions for automated deployment of system patches through a dedicated server.

The potential impact of a security incident includes endangerment of public or employee safety, loss of production, violation of regulatory requirements, harm to the environment and equipment damage. ABB evaluates all Microsoft security updates for relevance and system compatibility and published validation status as they are released by Microsoft.
